Monitoring and exploratory mission to India April 2018 Terms of reference

1 – GENERAL INFORMATION

1.1. Participants:

1.2. Duration of the mission: 10 days, from April 23, 2018, to May 2, 2018 (flight to be confirmed)

1.3. Terms of stay: based in Jodhpur and Delhi

2 – GENERAL OBJECTIVES OF THE MISSION

2.1. At the end of the mission, ongoing or completed PADEM projects were followed up, the results of which are transmitted to PADEM donors.

2.2. The presence of PADEM on-site is reinforced thanks to the identification of new partners and projects.

3 – SPECIFIC OBJECTIVES OF THE MISSION

3.1. Visit the intervention sites, meet the partners concerned and collect the information necessary to finalize the projects being designed. Obtain the additional information necessary to finalize these projects.

3.2. Visit the intervention sites, meet the partners concerned and collect the information necessary to develop the tools and monitoring reports required by PADEM donors on each of the projects in progress or completed.

3.3. Strengthen the PADEM network in India: identify new relevant projects to be implemented by PADEM with its current partners or new partners such as Care T and SBT for example.

3.4. Strengthen activities related to fair trade: carry out a good behavior charter with the current PADEM partner, identify and meet new partners.

A.5.4. Drafting and signing of a Charter of good behavior between Bisnoi and PADEM

A.5.5. Identify new producers already labeled F.L.O (Jodhpur and Delhi)

A.5.6. Contact these producers and meet them in the field

A.5.7. Analyze the "sales/production" capacities of these players and the compatibility of their activities with the intervention policy and the philosophy of PADEM, collect samples for future sales
